THIRD AMENDED ORDER CERTIFYING PLAINTIFF CLASS



1. The Motion to Establish Class Cut-Off shall be and herein is GRANTED;
2. The orders certifying the Plaintiff Class, dated December 17, 2002 and amended by orders dated March 31, 2003 and November 7, 2005, are hereby amended further to state that only persons who obtained a loan on or before December 17, 2002 are members of the class;
3. IT IS FURTHER ORDERED that this Third Amended Order certifying Plaintiff Class shall relate back to the date of the December 17, 2002 order certifying the class;
4. IT IS FURTHER ORDERED that the definition of the Plaintiff Class and the order certifying the class, as amended, shall in all other respects remain unchanged; and
5. The Motion to Strike is DENIED as moot.
